“Most people have firsthand experience with a loved one in a nursing home. The actual risk of the U.S. general population (over the age of 65) for needing long-term care (either skilled nursing or home care) is

70%,? says Martinez.

The focus of this seminar is to help consumers avoid going broke while paying for nursing home care.
