They must have worked in their specialty within the past six years and if selected for an audit, they must be able to show documentation that proves their experience. Candidates for certification must also be able to apply knowledge and skills needed for practice in the field, and must show attestation from a supervising physician who also works in their chosen field.

"As a physician assistant, we are trained to work in any aspect of the medical field," says Lisa Pearson.

Lisa Pearson says that in determining eligibility for the examination, applicants must undergo strict
