Recently Gross touched on how capital punishment in Florida was in a state of flux. This state essentially reduces the effectiveness of the legal system by slowing down the rate at which justice can be served. The personal injury attorney in Destin, FL, spoke on how appeals and mitigation were bogging down the justice system by stalling the convictions process.

?Many states are simply getting rid of the death penalty system,? Gross said. ?It just takes way too long and costs way too many taxpayer dollars.?

The laws concerning Florida?s death penalty cases have a reputation for changing. Previously, judges held the power to override a death penalty hearing; a method deemed unconstitutional and later changed. The personal injury lawyers in Destin, FL, express the issues with the constant challenges in the courtroom and

how it affects justice.

?It doesn?t matter if the killer is Ted Bundy, there will always be opposition. While some opposition is

necessary as a safeguard, most of it stops the killer from meeting justice,? Terence Gross said.

The personal injury attorney states that even with certified lawyers and zero appeals to sanity or competency,

punishment can still be delayed for upwards of 10 years. Gross suggests a 3-panel death penalty court

consisting of only expert attorneys who are death penalty certified. Although the laws are confusing, the town

of Destin is fortunate enough to have lawyers as reputable as Gross & amp; Schuster who will continue to

fight for justice and remain innovative.
