The IRS guide states that "it is a common practice for many professionals to own the property personally and lease it to a corporation or partnership where they conduct business." This means that they are concerned that business owners improperly jack up the rent in order to generate income, which can then be used to incorrectly absorb passive losses.

Clinton Robinson, on his website at <http://www.crprotax.com>, adds: "If the IRS sees you have this kind of arrangement, an alarm goes off and you could end up losing big money deductions, even if you use a separate entity like an S corporation to rent the property to your business. Luckily, you have two ways to avoid this disastrous result."

The two options that exist for businesses in this situation are the self-rental rule, whereby the income is classed as non-passive, but losses are classed as passive. This means that businesses lose out either way. The second option is to use the \$25,000 annual rental loss allowance. However, there are some stringent requirements that have to be met in order to be eligible for this.

People finding themselves trapped in the self-rental rule are encouraged to contact CR PRO TAX as soon as possible for comprehensive advice on how to get the maximum deductions while remaining compliant with the relevant IRS rules.
