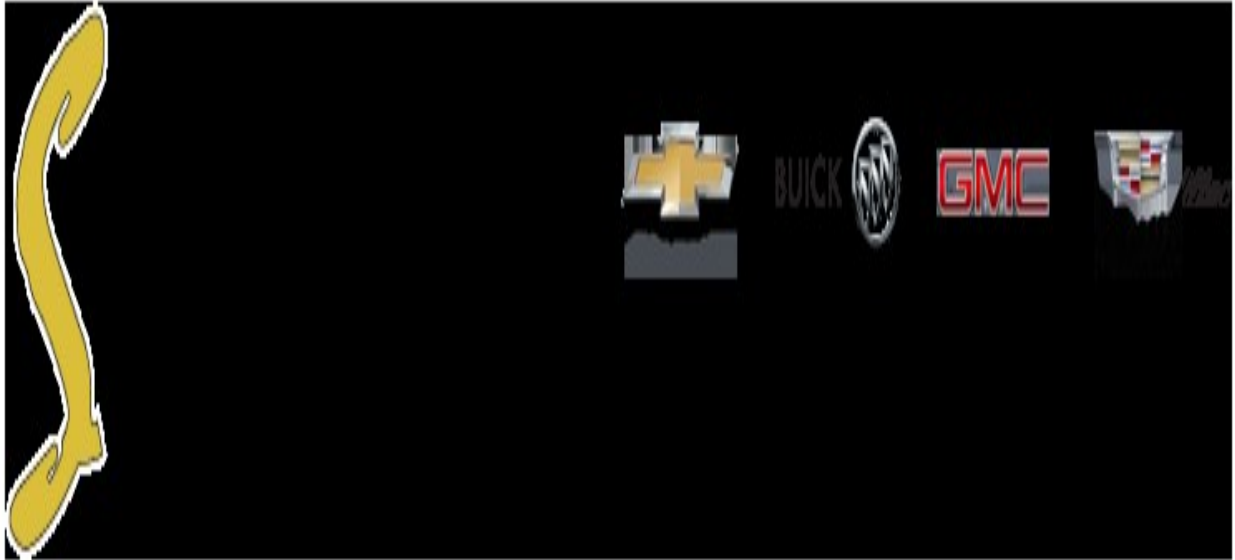




Connecticut Dealer Is Announcing The Arrival Of The 2017 Chevrolet Colorado ZR2
