Furthermore, in homicide accidents and drunk driving accidents, they may be able to seek punitive damages. Terence Gross himself has a background in DUI defense, which means that he understands the law like no other and is able to hold drunk drivers accountable for their actions.

He adds: "We also take cases that involve the aggravation of pre-existing injuries. While this will be a factor in the settlement/verdict, it does not mean that you don't have a case. In Florida, there is a jury instruction regarding pre-existing injuries that allows the victim to receive monetary damages."

The firm takes on accidents involving any kind of vehicle, from automobiles to jet skis. Meanwhile, although Gross & Schuster, PA only deals with cases that happened inside Florida, they do take on clients from other states, should the incident have happened while traveling through.
