There are a number of residential requirements that must be met prior to filing a petition for divorce. Specifically, the applicant or spouse must have resided in Texas for at least six months, and they must have resided in the county where the petition for divorce will be filed within 90 days.

Texas divorce law has also adopted the "no-fault" ground as part of their acceptable grounds for divorce. The

usual ground is: "the marriage has become insupportable because of discord or conflict of personalities that destroys the legitimate ends of the marriage relationship and prevents any reasonable expectation of reconciliation." In a few cases, it may be appropriate to allege other grounds such as cruelty, adultery, abandonment, living apart, etc

John K. Grubb adds: "One of the great things in Texas is that if you want a divorce, you can get it, whether your spouse wants one or not."
