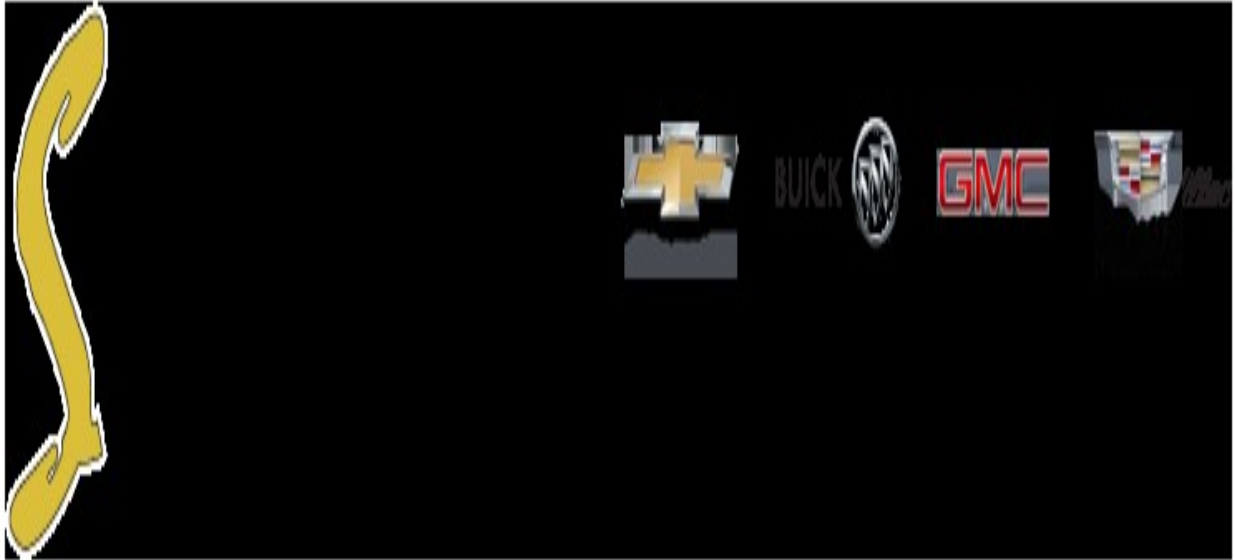




Connecticut Chevrolet Dealer Celebrates 20 Years In Business

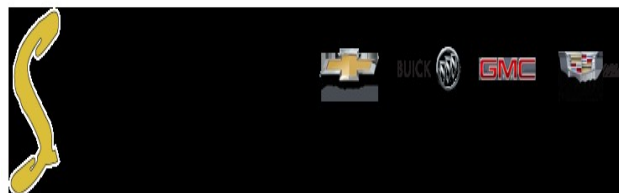
