

# CR PRO TAX Answers Question On ?Where To Get My Taxes Done? After Recent Tax Reform

For instance, they point out that the recent tax reform punishes W-2 employees because of the addition of Section 67(g), which states, "No miscellaneous itemized deduction shall be allowed for any taxable year beginning after December 31, 2017, and before January 1, 2026."

Clinton Robinson from CR PRO TAX explains how the tax reform has punished W-2 employees. He provides as an example, a W-2 mortgage banker who is paid on commission basis. In 2018, he is expected to incur \$27,000 in employee business expenses. With the tax reform, he cannot claim the \$27,000 as tax deduction for employee business expenses.

Clinton Robinson points out that this inability to claim a tax deduction on employee business expenses is unfair but people can get even. He provides as an example the case of Dan Butts, who is an Allstate insurance agent. Dan had to pay almost \$10,000 more in federal income taxes compared to what State Farm insurance agents paid because Allstate treated him as an employee while State Farm considered its agents as independent contractors.

Realizing the unfairness of the situation, Dan Butts decided to do something about it. He amended his income tax return and placed his W-2 employee commission income on Schedule C. He then deducted his business expenses from his Schedule C income and was therefore able to save almost \$10,000 in expenses. Naturally, the IRS immediately noted that Dan Butts had used the wrong tax form for his income and expenses. They then sent him a notice of deficiency for the almost \$10,000 in taxes. He refused to comply and took the IRS to court and he won.

Clinton Robinson points out that the court had agreed to grant Dan Butts independent contractor status even if Allstate Insurance paid him on a W-2, covered with pension benefits, compensated him for vacation days, paid 75 percent of his health insurance, matched his 401(k) contributions, paid part of his group life insurance

costs, paid his insurance licensing fees, and provided him with errors and omissions malpractice insurance. He explained that the court ruled in favor of Dan Butts because he had a "risk of loss" in his sales activities, which made him just like other independent contractors.

Clinton Robinson explains that those who believe they may be in a similar situation as Dan Butts can consult with CR PRO TAX to see if they have a good case. He urges them to contact him through the phone if possible.
