The Brown Firm focuses on personal injury cases, such as automobile accidents, motorcycle accidents, truck accidents, slips and falls, medical malpractice, work-related injuries, wrongful death, bicycle accidents, and

pedestrian accidents.

The firm's website features an FAQ section that seeks to provide information that guide people who may have been involved in an accident and want to pursue a personal injury case. For instance, one important question is what steps to take for those who have been involved in an accident. Other key questions include when to contact an attorney after an accident, the type of compensation that accident victims will be able to get, the amount of compensation, and how long a case will take.

In addition to the FAQ section, the firm's website also has a blog where various articles are available that are related to personal injury cases. Topics include various facts about pedestrian accidents, what people must do after a commercial semi-truck accident that was not their fault, what people must do after being involved in a car accident with an uninsured or underinsured driver, and the most common types of car accidents that cause whiplash.

Harry Brown Jr points out that motor vehicle accidents are the most common cause of injuries and deaths in the US every year. This is often due to the negligent actions of another driver. Meanwhile, the problem with motorcycle accidents is that riders are often more seriously injured compared to other drivers because the motorcycle provides very little protection when they get involved in a crash.

Meanwhile, truck accidents have a tendency to cause serious and lethal injuries because commercial trucks, such as tankers, rigs, tractor trailers and 18 wheelers, are very heavy and very large vehicles. To safeguard people, trucking companies have to follow strict government regulations regarding their operation, including the training and work schedules of the truck drivers.

For those who are injured by slips and falls in a property where the owner is negligent, it is possible to make owners be held financially liable for the injury, pain, medical care, suffering, lost income, and emotional stress resulting from the injuries. Some indications of property owner negligence are overly steep driveways or entryways; uneven or slippery sidewalks, pavement, stairs or other walking surfaces; poorly built or maintained structures; poor lighting conditions; and blocked aisles.

And then there is medical malpractice. The Brown Firm can also help clients in filing claims for medical malpractice, such as surgical errors, medication errors, misdiagnosis or failure to diagnose, and birth injuries.
