The number of claims in the consolidated MDL originally consisted of a few dozen cases, however the total number of Xarelto cases has grown rapidly since the formation of the MDL and now consists over 430 claims.

What Is Multidistrict Litigation (MDL)?

Multidistrict Litigation is a legal procedure often used in complex litigation including product liability suits. Multidistrict Litigation consolidates multiple lawsuits which share one or more common claims into a single filing under one district court.

Among other allegations, many of the claims in the Xarelto MDL allege that Bayer AG and Janssen Pharmaceuticals - manufacturers of Xarelto - did not warn about harmful side effects including irreversible internal bleeding, which they knew about.

Additionally, these lawsuits claim that sufficient testing was not performed on the drug to determine its safety.
