Savannah, Georgia-based law firm, The Brown Firm, has announced the publication of a new blog post addressing the rise of driving accidents in the U.S. that are caused by texting and driving. Harry Brown from the firm says, "The rise of smartphones has increased the number of accidents on the road, and deaths from distracted driving keep increasing every year. Many people might not realize what and what doesn't define distracted driving, and even more people don't know what kinds of actions they can take if they are the victim of a distracted driving accident."

In the post, the firm sites statistics from 2016, where distracted driving took 3,450 lives and 391,000 people were injured in distracted driving accidents. The National Highway Traffic Safety Administration says there are around 481,000 drivers using their cell phones during the day. "Imagine how much bigger the numbers are when you take into consideration the number of distracted drivers around during evening hours," Brown says. "And it's not just cell phones that cause these accidents, but a number of different behaviors."

Distracted driving includes more than just texting or talking on the phone, Brown states. Other kinds of distracted driving include eating, drinking, talking to passengers, changing the radio, applying makeup, or

programming a GPS. "Some of these behaviors may not seem very distracting because they're things that we do every day in the car," Brown says. "If they take your attention off the road, that's a potential accident. Many of these distractions can be avoided by doing them before you get in the car, or pulling over to a safe place to finish your task."

The top rated Savannah personal injury lawyer suggests that people know their rights when they get involved in an accident due to distracted driving. Brown says that if an accident occurs and someone was driving distractedly, a lawsuit can be brought against the person who caused the accident. "If someone has been texting and driving and injures a family member or yourself, you could possibly have your medical bills covered," he says.
