The company states that bats are a unique species in Michigan and that removing them takes someone with knowledge of the act. "Having bats in the house is not only frightening, but it can also be dangerous," says Scappaticci. "You wouldn't want to know the number of diseases that bats can carry and even though they may not personally mean you any harm, you have to understand that they can carry diseases and trying to eradicate them yourself is not the safest method of getting rid of them."

Scappaticci says that bat removal for bats in the attic takes professional knowledge. He says that many homeowners feel that they can swat at a bat and run it out of the house, but he continues that this is not true. Bats are common in the United States and finding them in a home's attic is not at all uncommon. The company says that bats congregate together in colonies so removing a bat is not typically the issue. If a homeowner sees one bat, it is very likely that they have an entire infestation of bats. It is for this reason that removing those bats should be left to a professional, according to Scappaticci. The company says that their new certification enables them to safely and effectively remove bats from homes or business buildings in and around the Oakland County, MI area. They state that as common as bats are, they can carry rabies and other diseases and have to be handled with care. Scappaticci says that it takes special skill and education in order to know how to remove bats without risking one's health and without running the risk of them coming back. He says that the methods used by Platinum Wildlife Removal are very effective and says that the company can help home or business owners to avoid having these issues in the future.

The company states that their bat removal services help to prevent issues of bats returning. They state that their bat removal services are a bit more humane than others. Some pest control companies simply spray foam in bat entry points or otherwise exterminate bats, leaving them dead in the home, which Scappaticci says creates an entirely different mess for the homeowner. He says that their company inspects the home to determine the level of infestation and then begins the bat removal process, without simply killing them or harming the bats in the attic. He states that the bat removal process begins with exclusion devices that will enable bats to leave the home at night but will not allow them to renter where they originally got in. These one way doors can remain in the home for an unlimited period of time to prevent bats from returning. The company states that the removal of bat guano, or bat droppings, is the last stage of the removal and although optional, is a very important part of getting the home cleaned and free from all bat remnants.
