As a Palm Springs Personal Injury Attorney, Cortright has seen a number of different cases over the years. "These kinds of cases encompass a variety of injuries," Cortright says. "Automobile accidents, pedestrian accidents, bicycle accidents, and even dog bites are all considered personal injury cases."

Cortright says that staying calm and remembering one's rights is vital after an accident occurs. He suggests first that once the vehicles are safely off the road after an auto accident to take down as much information as

possible. This information includes license plates, phone numbers, and other contact information. If one's smartphone is available, pictures should be taken and any numbers of the other drivers should be verified. Cortright also suggests telling the police all the facts as remembered without giving any opinions on fault.

"When an accident happens, there are a number of things that need to be arranged," Cortright says. "From car rental fees, to lost work time, to medical fees, and vehicle repair or replacement, there are a lot of stresses and you deserve fair compensation. My team's experience in personal injury cases will protect you and make sure you don't get bullied into a bad settlement."

Cortright says that employer may even threaten termination if an employee reports a work-related injury, but firing someone after they have been injured on the job is illegal. "If you get injured, whether it's an immediate injury or a long-term work-related injury, you should seek medical attention right away, as well as give us a call," Cortright says. "We will aggressively fight for your case."

Cortright has also helped many people out of their financial struggles as a Palm Springs Bankruptcy Attorney in Southern California, through both Chapter 7 and Chapter 13 filings. Chapter 13, Cortright says, is more for average to high income earners who are behind on their house, car, or HOA payments and wish to catch up to be current. These types of earners have their debts consolidated into a monthly payment with no interest.
