Brown says that seeking medical attention is the first and most important thing that needs to be done. He says that regardless of whether or not the passenger feels that they have been seriously injured, seeking medical attention is critical. There could be underlying injuries that may not show up for days or even weeks after the accident. Brown says that it is crucial that those involved in any accident seek medical attention first and foremost.

The attorney says that the second thing that passengers need to do is to determine fault and this is where an experienced attorney can help. He says that the average consumer may not know how to correctly determine fault and that even if a police report is filled out, there may be questions about the reason for the accident. The fault could lie with another driver in another vehicle or in the case of many texting and driving accidents in the US, the fault lies with the driver of the vehicle in which the injured is a passenger. In these cases, Brown says that the fault clearly lies with the driver who is breaking the law by texting and driving. There are a number of cases every day in which drivers carelessly text while they are operating a vehicle and despite the fact that this is illegal, many still do it.
