Roth states that in most accidents, someone is at fault. In the case of accidents caused by tires, the fault may lie with the driver of the vehicle in question or it could be an issue with the manufacturer of the tire. He states that when these accidents occur, it is essential that consumers have an experienced attorney by their side to help them to determine where that fault lies and how to handle the case.

In the event that the tire manufacturer is at fault, Roth says that the injured consumer will need to pursue the manufacturer for compensation. He says that in some cases however, the fault lies with the driver of the vehicle whose tire caused the incident. He states that not regularly checking the air in a car?s tires could lead to such accidents as under or over inflation can cause a tire to blow, and if this happens while the vehicle is traveling at a high rate of speed, it could very well affect other drivers on the road.

He says that in the case of accidents where tires blow and the driver of the car in question is injured, it may be necessary to look into the tire manufacturer to see if there were certain safety standards that were not kept. If a tire manufacturer knowingly distributes faulty tires, the attorney states that the drivers of vehicles that use those tires may have a legal stance against that manufacturer.

Roth says that the article on the firm?s website gives consumers information about what could potentially cause a tire to fail and the repercussions that could ensue. He states that the information also includes a detailed list of what consumers should do if and when they are involved in any car accident. He says that the first step is always to ensure that the driver and any passengers in the vehicle do not require medical attention. The second step is to file a police report, which is used to document the accident, something that is needed if the case goes to trial.

Roth states that his firm regularly provides consumers with information on things that they need to know in order to protect themselves in the event of an accident. The firm recently published information on getting your medical bills paid, which can be seen on their news page.
