For instance, blood alcohol level does not always have to measure at least 0.08 in order to be charged, as police officers may also use their observation to make this determination. The attorney explains: "If you are swerving a vehicle, driving across two lanes, nearly having a collision, erratically braking, missing stop signs, being overly cautious, taking turns too narrowly or widely, or drifting, then an officer may charge you with a DWI/DUI even if your blood alcohol level does not reach 0.08."

Those who are charged with a DWI could lose their license for 90 days to two years. Refusing to take part in a breath test as a commercial driver can lead to the commercial driver status being revoked for a year. A suspension notice may be provided by the arresting officer. This also requires immediate legal help, which the Butler Law Firm can provide. They will then review the entire process to determine that the law was followed and take appropriate action to minimize the consequences of the arrest.
