They are able to file for Chapter 13 Bankruptcy, and can reap immediate benefits such as an automatic stay, meaning that as soon as the bankruptcy is filed creditors and debt collectors are ordered by the court to immediately stop calling and sending bills. There are also long term benefits explained in the interview by Palm Springs Attorney Kevin Cortright, such as consolidating bills and restructuring them into one much more manageable payment a month that goes directly to a bankruptcy trustree. This way, the stress is taken off the debtors shoulders that comes with constant bills in the mail and phone calls from many different debt collectors.

Although there is a common stigma that filing bankruptcy is either ambarassing or scary, Mr. Cortright

assures all of his clients that those considering the process should learn more about all of the ways that it is

actually the exact opposite. He puts all of his clients at ease and helps to stop common problems that arise

with large debts such as being behind on house payments and facing forclosure. He can help those

interested to not lose their property and to restructure past due mortgage payments in a way that works better

for everybody.

Beyond mortgages, Kevin Cortright explains that there are many other types of debt that can be restructured

to eliminate the interest rate such as taxes, credit cards, mortgages, car payments, etc.
