There is a connection between suicide and TBI because this can affect the brain's functions, which can result in psychological problems like poor planning, poor memory, more difficulty in managing relationships, increased stress, and poor ability to manage their own emotions. Some victims of TBI may become more impulsive, think differently regarding certain things, or find it difficult to consider other perspectives.

Other factors that may contribute to a TBI victim's depression and resulting suicidal thoughts includes employment problems, bad news about prognosis, holiday times, frustration over tasks, lack of support, lack of connection, social anxiety, loneliness, and lack of resources. Because of the emotional disability and distress that they are undergoing, suicide may seem like a way to escape what seems to be an unsolvable problem.

As such, both the victims and their loved ones and caregivers have to be educated regarding the risk of suicide and how to recognize the signs when there's a need for prompt intervention. Examples of warning signs are victims threatening to hurt or kill themselves; writing or talking about death, suicide or dying; increased use of drug or alcohol; feeling trapped and hopeless; anxiety; withdrawal from friends, family or society; drastic changes in mood; feeling like giving up; anger and rage; sleeping too much or inability to sleep; and recklessness.

Victims and their loved ones and caregivers can minimize suicide risk by getting rid of access to lethal substances or materials at home, utilization of mental health resources, and continued support from loved ones.
