He warns that they will likely make several attempts to get in touch, but people who got injured from an accident need not talk to them and that it will always be a good idea to have all conversations with them coursed through a personal injury attorney.

Harry Brown Jr. DC, JD also warns people who got injured in an accident that the insurance company will likely want to ask about their symptoms and injuries and will later use the answers provided to reduce the settlement amount. Thus, it is always advisable to have a trusted attorney to handle those questions.
