Vida Melroy, a spokesperson for Melroy Property Management, says, "The rental lease contract is effectively an agreement that the leasing party will pay the manager a specific amount of money in exchange for the right to legally occupy the space for a designated duration of time. Regardless of the details, the lease is typically an enforceable agreement that designates legal authority to collect the rental fees unless a tenant can legally claim a pre-designated exception. This is the basic element of property management in San Diego, and all professional leasing agents know these problems can arise for their tenants."

One such condition is unacceptable maintenance. The law requires landlords to maintain the property that they are offering for rent for regular occupancy. A tenant can send a written notice to the landlord and then

file a claim with a government agency. That tenant can often break a lease when the landlord fails to repair the problem shortly after receiving the notice. By ensuring that the property is regularly maintained and all needed repairs are attended to, the property management San Diego company can help the property owner avoid such problems.

Another condition is unlawful entry. Landlords are typically not allowed by law to enter a tenant's unit without at least 24-hour notification. And even with a notification, there are some restrictions with regards to a valid request for entry. Any unlawful entry incidents can be used by the tenant to break the lease. Property managers are knowledgeable about such restrictions and will ensure that they comply with them to avoid problems with the rental lease.

Military assignment is another potential basis for a tenant to legally break a rental lease. This is because military personnel do not have any control on where they are assigned. Property managers know about this condition and anticipate such a possibility when renting to military tenants.

Domestic violence is another issue that can allow a tenant to end a lease. Those who have been victims of domestic violence can often break a lease by claiming safety issues in some cases. However, such incidents should be reported to the police for appropriate documentation. Property managers are well aware of such potential problems and always strive to make their facilities safe for all tenants.

Notwithstanding the above exceptions, it is important to understand that tenants cannot simply break a rental lease without some legal action being taken against them. Leases are generally binding contracts with only a few loopholes. Thus, entering into a lease contract is a serious financial transaction that should be carefully assessed beforehand by the leasing party.
