There are many types of personal injury claims. These include automobile accidents, bicycle accidents, slip and fall accidents, workplace accidents, defective products, medical malpractice, dog bits, nursing home abuse, construction accidents, and premises liability.

Automobile accidents are quite common on the streets and highways of Georgia. A motor vehicle crash can result into a number of injuries, such as head trauma; broken bones; neck, back and spinal cord injuries; and permanent scars and disfigurement. Medical malpractice can occur when a medical provider?s negligence resulted into serious injuries or even death. The laws on medical malpractice are designed to protect people from reckless or negligent behavior from nurses, doctors, medical technicians, anesthesiologists, and more. Some of the common causes of medical malpractice are lack of training or experience; improper testing or missed diagnosis; fatigue; and improper administration of anesthesia or medication.
