Dealing with this was our foremost priority and we, unfortunately, had to replace different materials which presented different stages of mold growth."

Due to the myriad health risks that mold growth poses, these cases must be handled carefully by a licensed professional. The company affirms that this is the only way to ensure every trace of the threat is removed from the area. Bio Clean of Utah relies on the best technology available to ensure every speck of mold is removed, though there are different materials which can not be properly cleaned and must be completely replaced.

While Bio Clean found other areas that did not present a mold growth, those sections of the property had nonetheless sustained a great amount of water damage. The company states that the drywall, its insulation, and the carpet had to be dried and properly cleaned, which they were able to do with a dehumidifying device. This equipment reduces the level of humidity in the area it is employed, preventing the swelling and warping of floors, walls, and furniture.

Olsen says, "Our method of dehumidification saves property owners, businesses, and insurance companies money in restoration and replacement costs, as well as the difficulty in calculating the cost of downtime and delayed deadlines. We have the power and capability to remove all water and moisture from drywall, plaster, interior paint, cement floors, carpet, and insulation."

The Sandy residence project was a total success, as the company was able to effectively remove any signs of the water leaks which had been going on for months. The residents of the household expressed their gratitude towards the company, commenting that they were very thoughtful and caring throughout the restoration process.
