They want to point out that chiropractic care is a non-invasive type of medical care that is used for treating muscle and joint issues including but not limited to, neck pain, back pain, headaches, and pain in the joints of the legs and arms. Chiropractic can also help to eliminate misalignments in the spinal column, with the result of restoring proper nerve communication and innervation from the brain to the body, so that all organs, tissues, and muscles are operating at their maximum level.

The misalignments are eliminated by the chiropractors through specific manipulations or adjustments to the affected joints and tissues. The joint manipulation is designed to restore joint mobility through the manual application of a gentle, controlled force to the joints that have lost their normal movement due to an injury. These treatments have been observed to help relieve acute pain symptoms, get rid of soft tissue adhesions, and decrease muscle tightness.

The joint injuries could have been caused by a single traumatic event, such a car accident; a slip and fall; or repetitive stresses, such as sitting in an awkward position with improper spinal posture for long periods of time. If these joint issue and injuries are not treated promptly by a skilled chiropractor, the tissue that connects the joint structures will become extremely taut, causing adhesions called trigger points. Furthermore, because the joint is limited in its range of motion, the fluid that usually hydrates the area is not able to properly lubricate the joint, thus allowing arthritis to set in over time, which then worsens the pain in the area.
