In the state of Florida, accident injury victims are only given a maximum of 14 days to get treatment for

accidents where a personal injury lawsuit is necessary. If treatment is not received before that period has ended, any injury resulting from the accident will be excluded. Thus, it is advisable for the victim or the family of the victim to call Florida Spine and Injury to schedule a Free Accident Injury Consultation as early as possible. This allows them to have a chance to get financial compensation.

It is advantageous for victims of an accident to get treated by the team of chiropractic and medical doctors at Florida Spine & Injury who have years of experience in treating accident injury victims in Florida. They can offer treatment for a variety of symptoms and conditions. These include neck pain, back pain, knee pain, whiplash, neuropathy, sciatica, and scoliosis.

When accident victims go to the Florida Spine & Injury Clinic, a chiropractor in The Villages Florida conducts an initial consultation. The chiropractor will run diagnostic tests to find out the extent of the injuries and later establish a treatment program so that each patient has the best chance to fully recover from their injuries. Before the diagnostic tests are performed, the doctors at the clinic will first conduct an investigatory exam.

Next, a physical exam is conducted. This exam will include testing for muscle strength, range of motion, and a questionnaire allowing the doctor to better comprehend the symptoms. After the physical exam, the diagnostic tests are then performed. These include X-Rays, MRIs, CT scans, and more, depending on the type and severity of the injury.

The clinic offers help for personal injury victims. A personal injury is an injury of the body or mind caused by another person's negligence which leads to a tort lawsuit. Personal injuries are usually the result of car accidents, truck accidents, motorcycle accidents, boating accidents, bicycle accidents, pedestrian accidents, slip and fall accidents, work accidents, sports accidents, or product accidents. The victim might be entitled to monetary compensation if the accident was due to negligence. The team at Florida Spine & Injury can help victims not just with treatment and healing, but also in providing documentation for filing a legal case against the careless party.

Treatment options for accident victims include spinal decompression, physical therapy, and rehabilitation exercises. Spinal decompression is a non-surgical procedure where gentle distraction of the spinal joints in the neck or lower back is performed with a computerized traction device. Those who suffer from sciatica, bulging discs, degenerative disc disease, disc herniation, and chronic neck or back pain usually respond best to spinal decompression therapy.
