This should be done even if the injuries seem to be minor. It has to be reported to the local police department so that a police report can be filed.

The second step is to seek medical attention as soon as possible. This should be done even if there are no apparent injuries. This should be done because if injuries are later discovered, delayed treatment may decrease the opportunity to receive damages.

The third step is to get the other driver?s contact information. The other driver should not be allowed to leave the scene without providing his or her contact information. However, care should be taken not to mention that the other driver is being blamed for the accident.

The fourth step is to get a detailed police report. A thorough police report can dramatically increase the veracity of the victim?s claim. The advanced training of a police officer will allow him or her to competently evaluate the crash scene and determine fault.

The fifth step is to gather own evidence. The victim can take pictures of the accident scene, the cars involved and any unique features of the surrounding area.

Step six is to talk with potential witnesses who actually saw the accident. They can serve as valuable witnesses who can corroborate the victim?s story.

The seventh step is to contact the insurance company to inform them about the accident. However, people should be aware that the insurance company may pressure the victim into a settlement immediately. If such is the case, the victim should let the insurance company know that the accident is still under investigation.

The eighth step is to schedule a free consultation with a car accident lawyer regarding the different legal options if the victim feels that it was the other driver who caused the accident. And even if the victim is partially to be blamed for the accident, he or she might still be able to file a claim for compensation.
