They provide bail bonds in Phoenix for various situations, such as: assault and battery bail bonds; DUI bail bonds; spouse abuse and spousal abuse; domestic violence bail bonds; marijuana offenses bail bonds; larceny bail bonds; criminal threats bail bonds; burglary bail bonds; immigration bail bonds; narcotics and drug offenses bail bonds; robbery bail bonds; felonies or felony bail bonds; federal bail bonds; and more.

Signature bail bonds, no collateral bail bonds, or zero down bail bonds are ideal for people who are not a homeowner or do not have any equity in their home to apply as a down payment. This will also require job stability, proof of income, good credit history, and 10 percent of the bond to be paid in cash or through debit or credit card. The applicant must also be willing to be financially liable for the full bond amount in the event that the defendant fails to appear in court and/or the bond is forfeited.

Most jail facilities will refuse someone to post bail with a debit or credit card. However, Bailed Out Bail Bonds can charge the card and then have one of their agents post the bond for the defendant. An important feature of the service provided by the agency is that it will take them only about 5 minutes to go through the bond process and have the defendant released from custody as fast as possible.

They also offer their services for cash only bail bonds for the whole state of Arizona. Clients can send the funds by Wire Transfers, Western Union, MoneyGram, or PayPal. They accept all forms of cash bond payments.

Bailed Out Bail Bonds also provides a GPS monitoring service, which involves the use of a high quality GPS monitoring device that will allow the monitoring of the location of the accused. Those who want to be released but pay less for bail can use this system. The reason for using the GPS monitoring device is to minimize the possibility of the accused not appearing in court at a later date. Because there is assurance that the defendant will return, a lower amount of bail may be imposed. Furthermore, the GPS monitoring device is lightweight and will not feel inconvenient for the defendant. The bail amount will drastically decrease as soon as the GPS monitoring device is added into the equation.

It should be noted that it is not the bail bond agencies that set the bond premiums. They are established by law, and in the state of Arizona, 10 percent is the legally mandated premium to be charged on the bonds. However, Bailed Out Bail Bonds can also help in making the bonding process more affordable. They can help clients deal with the payment of a bond premium in a number of ways, such as the use of credit or debit cards. While payment through credit or debit cards is not accepted by the courts, the bond agency is willing to accept full or partial payment through them.
