



## **Meth House Testing Services Offered By AEI Decon**

It should be noted that exposure to the chemicals found in meth labs is dangerous to people and pets as well as the home. The chemicals that are used in manufacturing methamphetamine are mostly dangerous and some are flammable and are therefore potential causes of fire, explosion, and various health issues.

There are a number of things that people who suspect the presence of a meth house or meth lab should do. These include leaving the site immediately and informing the authorities about the location; not touching or opening anything in the suspected site such as boxes and other containers; avoiding spending time inside that house; making sure that the meth lab owners are not alerted; and avoiding the shutting off of the electrical supplies for that house or apartment unit. If the unit is already vacant, it may be a good idea to contact AEI Decon to perform meth testing.

While there are many stereotypical signs that people expect to see in a math lab or meth contaminated house, most contaminated properties are not obvious. In fact, most of the homes AEI Decon decontaminates have no clear indication of methamphetamine use or manufacture. It is impossible to identify a meth house or contaminated property without proper testing. This is why industry experts recommend that all properties be tested, whether they have visual signs of meth use or not.

Unfortunately, such cleaners are only partially effective, leaving some of the residue behind that can recontaminate the house interior. Neither does painting over the residues work because, in time, the toxins will seep through the paint and contaminate the home.
