Notably, however, Attorney Robert A. Dodell cautions that no online BAC calculator or chart can be completely accurate. This is due to the fact that a person's BAC is influenced by a variety of factors. While the firm's new online calculator will take the number of drinks consumed over a certain period of time (along with the individual's body weight and gender) into account, their BAC will likely vary based on multiple other factors. Furthermore, an online calculator cannot account for the complex chemical interactions that occur in their body should the individual also be on any medication, prescription or otherwise. Drivers are therefore advised not to rely too heavily on the accuracy of their online BAC calculations.

This also applies if you are only charged with a misdemeanor.?
