As the office notes, the regulations prohibiting healthcare fraud are both specific and complex. When a person is charged with a healthcare fraud violation, their conduct can and will be punishable under a variety of federal statutes. Depending on the accused's situation and the evidence against them, the office states that reducing or completely dismissing these charges is possible, though it greatly depends on the situation at hand.

Failing to have the charges dismissed puts the accused in dire straits, as the broadest statute prohibiting healthcare fraud is already quite severe. It punishes by fine and/or up to 10 years in prison the knowing and willful execution of a scheme to defraud a healthcare benefit program, or obtain by fraudulent pretenses, representations or promises, any money owned by or under the control of any healthcare benefit program. Even in cases where the accused's conduct does not rise to the most punishable levels, the most common consequences of these charges often include significant fines and up to five years imprisonment.
