New Jersey has heavily congested roadways and a long, crowded rush hour. Inevitably, this leads to many motor vehicle accidents on the roads that lead to thousands of people being injured every year. More than 60,000 are injured across New Jersey annually?many of them seriously?and this is an indication that most drivers will likely be involved in a wreck at some point. In these situations, however, far too many motorists injured in these accidents accept an early settlement from the insurance company without fully realising the implications of doing so.

Of course they should know that there is no obligation to accept the first offer. It should be seen as a negotiating position, and the first offer will, naturally, be very low." In reality, being in an auto-wreck is not something that many people plan for, and victims of accidents can end up in public hospitals. Often, while they are enduring pain and disruption to their lives, they are also worried about the costs that are incurred from such prolonged periods of recovery and rehabilitation.

Understandably, this adds considerable mental strain in what is already a trying and difficult time. Victims can be faced with devastating financial burdens in these situations; it is widely acknowledged that over 60% of bankruptcies in the USA are due to medical bills. Extra costs after a motor accident can come from three sources: the loss of property, lost wages, and the medical expenses themselves, all of which may be caused by the negligent acts of other parties.

While victims are in pain and worried about the financial impact on their loved ones of these sudden and catastrophic events, they are often approached by insurance companies offering low-ball offers to settle quickly. This may seem attractive as the victim may want to settle up and have some money to pay bills, but the firm asserts it is unwise for people to accept settlements offered in this manner.
