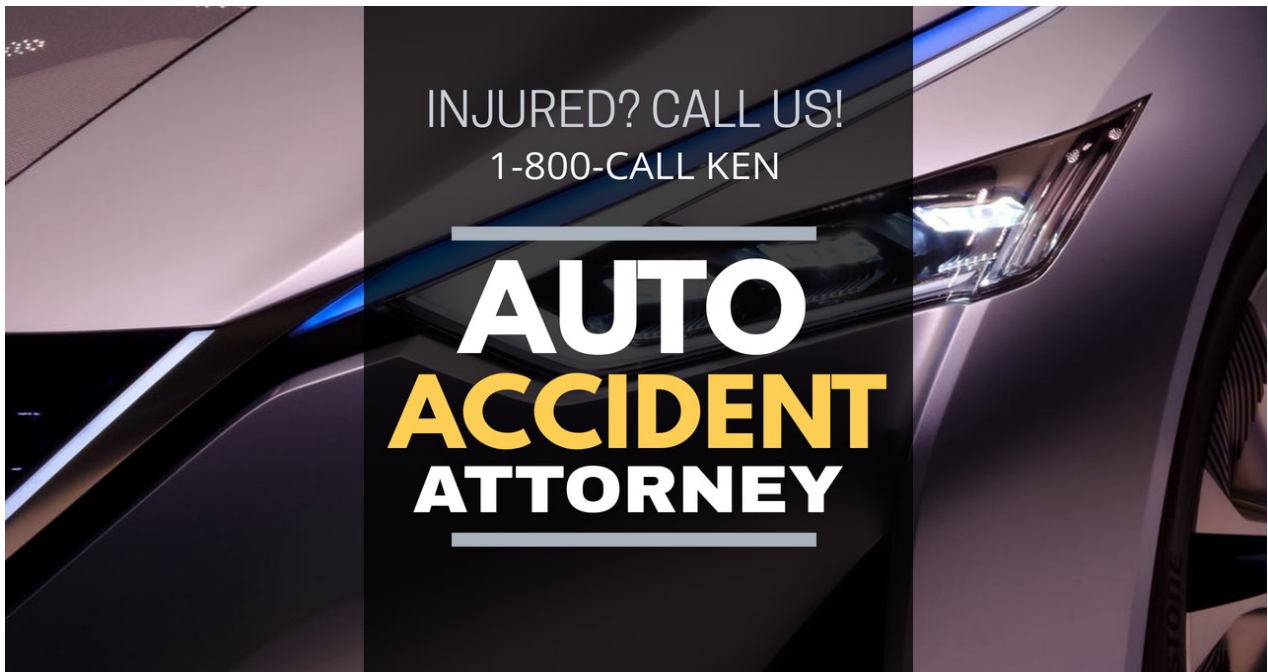




## **Atlanta Auto Accident Attorney Firm Offers Help to Car Accident Victims**
