According to ICBB, the price of these devices is often beyond the budget that many people have access to, even though back braces are a crucial part of a person's therapy and recovery from back pain. This leaves most individuals at a loss for what to do if they can not afford the equipment. In these situations, as the company states, those under Medicare are often eligible to have the cost of their braces covered, enabling them to pay little to no money at all for their crucial therapy gear.

To receive this insurance covered equipment, there are only a few requirements to be met, as Medicare takes the patient's symptoms into account when evaluating their condition. The most important requirement is to possess a written prescription from a doctor who attests to the patient's symptoms and condition, specifically recommending the use of a back brace to improve their back pain. The coverage of Medicare for back braces depends on the patient's situation as well. For instance, ICBB states that Medicare A applies to their case if they are hospitalized, covering the totality of the equipment's cost. If they are not hospitalized but have a prescription for a back brace from a doctor, Medicare B covers 80 to 100% of the cost of their brace (as long as the braces are purchased through a Medicare-certified provider).

This is where ICBB and MedSource come in. They are certified providers who supply two types of back braces of the highest quality: the Comfortland Delta 59 and Delta 37. Both of these variants are able to achieve the right compression, removing pressure from the patient's spine and providing the support necessary to remove discomfort and reduce pain.

Each of these back braces caters to a different type of individual with different lifestyles, as the Delta 37 is specially designed to allow a high degree of mobility without compromising the support it offers its wearer. It comes with both custom fit and universal sizing features that accommodate waist sizes from 25-68 inches, and it weighs only 1.5 lbs.
