The latest version of ISO 14001 is the ISO 14001:2015 and should be utilized by any company or organization that wants to establish, improve, or maintain an environmental management system that complies with the standard's environmental policies and requirements. ISO 14001:2015 is applicable to all

organizations, whatever the size, location, industry, or sector. It focuses on a number of topics with regards to environmental management systems. These are context of the organization, planning, leadership, operations, support, performance evaluation, and improvement.

The 2015 revisions include the integration of a required high-level structure with the use of mandatory definitions, and the incorporation of common standards clauses and requirements. The 2015 version has an impact on 10 major areas: expansion in EMS coverage and scope; new requirements for leadership management; required interactions with external parties; expanded legal compliance requirements; new documentation requirements; need for risk-based planning and controls; changes in competence and awareness requirements; expanded operational control requirements; increased certification costs; and effects on the internal audit system.
