Personal accident consultations are free of charge and the victim will learn much about the legal process they are about to go through. Most law offices such as theirs will even go to visit a victim in the hospital if that's what's required in order to give them their first consultation. He added that in personal injury cases there are no legal fees at any point in time during the process if a lawyer agrees to take on their case. The legal firm representing them does not get paid if the personal injury victim does not receive compensation for what happened to them. Because of this, if a personal injury claimant does then decide to go ahead and retain legal counsel, they will have a strongly motivated attorney working on their behalf.

The spokesperson added that Georgia law is very complicated when it comes to personal injuries.
