These mesh products have a tendency to shrink, shift, or migrate inside the body following surgery and, as a consequence, many patients who have hernia meshes wind up suffering from recurrent hernias, chronic pain, infection and organ perforation. These hernia patients frequently wind up needing additional surgeries so that internal injuries can be repaired and defective meshes can get replaced. If you or any of your loved ones have faced any issues with hernia meshes, we're here to help you."

According to the firm, there has been an increased number of hernia mesh claims being brought against specific manufacturers in the United States in recent years. This is primarily due to the complications and side effects that have arisen, even after medical practitioners categorized these procedures as swift operations that only need limited time to recover.

US Drug Lawsuit says the most important thing for patients to do before lodging hernia mesh claims is to figure out what hernia mesh implant they have. McEwen Law Firm says, "The most critical initial step is to request your surgeon or hospital to assist you in determining which hernia mesh brand or medical device was used as your implant." This is due to the fact that, as the firm explains, legal actions are currently only being pursued against certain hernia mesh producers.

As they point out, C-QUR by Atrium and Physiomesb by Ethicon are two of the most problematic implants. Physiomesb was withdrawn from the market in 2016 after revelations that it led to a huge percentage of corrective surgeries. C-QUR's problem was that it was manufactured using an Omega-3 covering, which was originally intended to assist in reducing inflammation. However, the use of the Omega-3 covering backfired as many patients ended up facing extreme allergic reactions. The law firm also warns that it is critical for patients to be aware of the various complications which can be caused by hernia meshes. The complications highlighted by US Drug Lawsuit are hernia recurrences, corrective surgery/revision, extreme infections, erosion, severe pain, perforation of other organs, mesh rejection or migration to other organs, inflammation, and so on.
