The 501(k) allows companies to bypass crucial safety testing requirements when the FDA has already approved similar products. The only thing that manufacturers have to do is to demonstrate that their new product is as effective and safe or even significantly equivalent to any product already approved for sale.

Any time a hernia mesh device is granted fast-track approval, the companies making them can start marketing their new devices. There are no requirements for the mesh to go through any clinical trials or for the FDA to take a closer look. As a consequence, many defective mesh products wind up finding their way into various operating rooms, and thus also into patients' bodies.

McEwen says, "The most important thing you need to know is which hernia mesh device you have because not every hernia mesh product is created equally. Each mesh has its own distinct complications and risks.
