Ryan Garry explains, "In addition, the prosecutors in federal court (the United States Attorney's Office) usually have many more resources than those of state prosecutors. The United States Attorney's Office has the resources of the FBI, DEA, etc. and often cases are investigated for years before the United States Attorney's Office brings an indictment. Thus, federal lawyers can charge from \$10,000 to millions of dollars in legal fees."

The federal crimes that can be handled by the federal lawyer MN residents can depend on, involve terroristic threats, Internet and media crimes, and crimes of terrorism.

Internet crimes may involve federal computer fraud or federal copyright infringement. Federal computer fraud is governed by 18 U.S.C. Section 1030, which is a very long and complicated statute. For instance, a person can violate the statute by accessing a computer without having the proper authorization or exceeding the limit of authorized access and obtaining protected information and that such information could possibly injure the United States. It is vital to get the services of an Internet crimes attorney when charged with an Internet or

media crime.

Meanwhile, federal copyright infringement is governed by 17 U.S.C. Section 506 and 18 U.S.C. Section 2319. Those who knowingly infringe on copyright for financial gain could be punished by up to five years of imprisonment, and or a fine.

The crime of terroristic threats occurs when a person threatens to commit a crime of violence for the purpose of terrorizing another person or to evacuate certain areas, or in reckless disregard of being able to cause terror. This crime may also be committed by a person who communicates with another person with the goal of terrorizing another person or in reckless disregard of causing terror. The penalty for this crime is imprisonment of up to five years and/or a fine of up to \$10,000.

In Minnesota, it is possible for a person to commit a crime in furtherance of terrorism if the crime is regarded as a felony and is premeditated and violent to property or people with intent to terrorize, intimidate or force the public and the intended victims and disrupt the lawful exercise of assembly, commerce, and government. This particular crime has a penalty of up to half of the maximum of the underlying crime. Essentially, a convicted person could be subject to 150 percent of the maximum of the underlying crime.
