

MN Criminal Defense Attorney Receives Top 3 Criminal Defense Attorneys in Minneapolis Award

Ryan Garry - Criminal Defense Attorneys, a law firm based in Minneapolis, Minnesota, has revealed that their team of lawyers have gained recognition for being the "Top 3 Criminal Defense Attorneys in Minneapolis." This award was based on several criteria and does not involve a paid legal directory. The criteria includes legal history, reputation, overall ratings, complaints, near me data, client satisfaction, trust, and cost. The Law Offices of Ryan Garry, LLC is a firm that represent individuals dealing with accusations and criminal charges brought by the state or by the federal government.

Ryan Garry is just one of the few lawyers recognized by the Minnesota State Bar Association as a Criminal Law Specialist. This is a certification that is held by less than 3 percent of all criminal defense lawyers in the state. Furthermore, all of the lawyers in the firm have been recognized by their fellow attorneys in the state as either a Rising Star Superlawyer or a Superlawyer, which are designations held only by the top 5 percent of criminal defense lawyers. In 2018, Ryan Garry also received the Top 100 Lawyers in Minnesota Award.

Ryan Garry recalls how he started, "I am the first lawyer in my family. Thus, I started the firm from nothing, and hung up a sign and started trying criminal jury trials. While most lawyers have had wonderful mentors along the way, my success is a direct result of getting in the trenches and going to trial " as that is the way to become a true trial lawyer." Aside from the awards and recognitions mentioned above, Ryan Garry has a 10.0 Avvo rating, which makes him one of the top Minneapolis criminal justice lawyers.

His most recent victory resulted in the head prosecuting attorney deciding not to file charges against his client, who was being investigated for criminal sexual conduct. This was an eight month battle with a county attorney's office in western Minnesota. It turned out that the "victim" was just lying and made up the whole story. The investigators for Ryan, who are former federal agents for the government, conducted a very thorough investigation that showed the victim had been lying.

The Ryan Garry law firm offers various criminal defense services. These include help for charges of violent crimes, sex crimes, drug crimes, white collar crimes, driving crimes, and expungement. Violent crimes include murder, manslaughter, arson, criminal vehicular homicide or injury or operation, kidnapping, robbery, burglary, assault, and domestic assault. Sex crimes include criminal sexual conduct, prostitution child pornography offenses, and engaging in prostitution. White collar crimes include identity theft, theft, and bribery. Driving crimes for cars and boats, are primarily about driving while intoxicated.

The firm also offers help for expungement, which results in the elimination of criminal records. With major changes to the Minnesota expungement law in 2015, people now have a decent chance of erasing their previous mistakes and beginning anew. This means that majority of criminal convictions will at some point in time be eligible for expungement. There are two kinds of expungement: statutory expungement and inherent authority. There are certain kinds of cases that almost guarantee an expungement in Minnesota. Expungement is provided for cases that have been resolved in favor of the accused, unless an agency holding the records is able to prove to the court that the records should not be expunged. These cases include dismissals, acquittals, continuances for dismissal, stays of adjudication, and diversion cases.

Those who are not qualified for a ?presumptive? statutory expungement will need to prove to the court that they deserve an expungement. For this, they will need the services of an expert expungement lawyer. The second type of expungement is inherent authority and it can only expunge court records, which means it is not of great help unless there are no records held by any other branch of government.
