If you are thinking of studying law and establishing a career as an attorney, you'll need to go through a number of critical steps. Most attorneys attend a four or five-year undergraduate college after high school, then at some point attend law school for three or four years and then sit for the bar, which will give you the license to practice. You also need to prove you can provide competent legal help to others. Once you've started your career, you will then need to stay up to date with legal developments so that your clients get the best and most current legal advice."

Ryan Garry LLC explains that the first qualification needed to become a lawyer is a bachelor's degree. While most law students tend to major in disciplines such as history, political science and English, the major itself is not actually important. What matters is choosing challenging classes that emphasize critical reading and analysis, projects, organization, writing and research.

After a bachelor's degree, the law firm explains, attorneys must complete law school to qualify themselves to practice. Before getting into law school, students must pass the LSAT (Law School Admission Test), which assesses a student's potential for the study of law. Once they pass the LSAT, students will then study for three years to earn the required degree, which is a juris doctor, abbreviated to JD.

Ryan Garry states that some schools also offer specialization and certificate programs for those who want to focus on a particular area of law. According to statistics shared by Ryan Garry LLC, popular specialization

programs include international law, intellectual property law, litigation and business law. Some students may also choose to obtain a second advanced degree. In these joint degree programs, students can earn a JD/MBA, which was the top student choice in 2011.

The bar exam, on the other hand, tests students' knowledge of all legal matters, and it is required by all states for licensing. According to Ryan Garry LLC, each state sets its own particular criteria and, if someone wants to practice in more than one state, they must pass the bar in both states.
