Meanwhile, as noted on The Soliman Firm's website, the Federal Motor Carrier Safety Administration (FMCSA) has set out a strict set of rules and regulations that is designed to keep truck drivers and the general motoring public safe on the road. For instance, FMCSA requires that trucking companies must have at least \$750,000 in insurance on each truck that they own, and those who fail to meet the requirements are prohibited from operating on the roads. Next, truck operators must keep detailed inspections and maintenance records to ensure that their trucks are not only in good condition but also operating as they should be. When a truck accident occurs, a victim's lawyer can also demand these documents from the trucking company to be used as evidence in court.

Finally, FMCSA requires truck drivers to adhere to specific safety guidelines such as attending regular safety training programs and refresher courses. They are also required to keep a log of their driving hours to ensure

that they do not exceed the maximum limit defined by the law.

Soliman states that dealing with the aftermath of a truck accident is a long and complicated process and only a professional truck accident attorney can protect a victim's interests. It is not uncommon for truck companies and their insurers to try to offer a settlement that is far below the true value of the claim. While it is tempting to accept such offers, Soliman recommends seeking help from a qualified legal representative who knows how to identify whether the settlement offered is fair or not.
