Hotels and banquet halls are among the most budget-friendly places to wed. Wedding dollars stretch further at dedicated event spaces through the magic of venue preferred vendors. Brides save time using venue approved providers avoiding the arduous interviewing, vetting, and hiring process for dozens of vendors. The impact of the time-saving benefits is not to be underestimated but pale in comparison to the budgetary impact on wedding costs. Thousands can be saved when approved vendor services come bundled together with an event venue.

Venues with a preferred vendor list usually allow off-list hiring, but not for free. Customarily event facilities charge an additional 20 percent for outside vendor privileges. To get the max for the minimum, pick a place with a preferred vendor list, and do not go off-list.

Every wedding season, couples will decide to save money on the site fee getting married at a private residence. Unfortunately, the cost to rent lighting, tables, tenting, decor, dancefloor, and more to convert the living space into a wedding venue consumes the amount of a sizable site fee and beyond. Unless the wedding is truly a no-frills occasion a residential venue is not a money-saver.

Similarly, the site fee for renting an empty loft space can look like a deal at first. But the savings are short-lived after factoring in outside catering, hired entertainment, bartenders, and servers plus rental fees for tables, chairs, china, glassware, and linens in addition to the cost of floral, valet, and photography services. Plus, more vendors, each with a set of delivery and pick up charges. The decision to marry at a low-fee or free venue is one the wedding couple ends up regretting for years to come.

To dramatically impact wedding costs, Title Tree, Title Pawn Lilburn, directs brides on a budget to turn to the guest list. Move a few from invited to uninvited status for an instant cash infusion. On the other hand, adding guests will skyrocket costs like nothing else. Look at the math. If the food and beverage cost per head is three hundred dollars. Take ten to twenty heads off the list to save three to six thousand dollars with the stroke of a pen.

After eliminating unnecessary guests from the headcount, look to the catering menu for ways to save money on wedding food. A few well-chosen menu alterations can profoundly decrease costs while going unnoticed by attendees. For example, save a dollar per head with the omission of cheese atop a seasonal vegetable salad. For more notable savings, replace roasted fingerlings with creamy whipped potatoes.

High-cost lavish ingredients, like lobster, make a memorable impression, in sizable portions as an entree or in tiny tidbits in a sumptuous appetizer. Lobster may not be thought of as one of the top ways to save money on wedding food, but it is. Going for the high-end appetizer is a clever way to serve much less lobster reducing wedding costs quite a bit while impressing attendees with a wonderful taste experience. To have a high-end wedding without paying the astronomical price focus on creating an experiential wedding that guests will remember for years afterward.

Do not splurge unnecessarily on top-shelf liquor unless you plan to bring the final wedding price tag to an all-time high. Know your crowd and be strategic. Consider red and white wine in addition to a domestic light beer and a local craft beer. Rather than serving a lame signature cocktail, pour one light and one dark liquor allowing guests to drink it their way. Skipping the signature cocktail will free up a thousand dollars or more for

better entertainment or additional food.
