However, the practical restrictions that come about as a result of such incidents tend to prevent these victims from seeking aid when they need it the most. The more catastrophic and life-altering the accident, in fact, the more likely it is that the victim in question will find themselves quickly overcome by problems they find themselves unable to overcome, including mounting medical bills and lost wages due to an inability to work. As a result, the firm urges accident victims to schedule a consultation with their expert attorneys as soon as possible in order to explore their legal options.

Accident victims also tend to find that insurance companies will reach out to them shortly after an accident in

order to produce a settlement offer that seems quite attractive at first. Instead, they seek to minimize the amount they will have to pay by preying on the victim's ignorance, especially since these offers are put forward before the true extent of the latter party's ensuing bills and losses become apparent. For instance, many types of injuries require ongoing care that form a cumulative and exorbitant expense. On the other hand, victims may also not consider the wages they will lose should they be unable to work, now or in the future (especially if their recovery does not proceed as planned). Knowing this, insurers will often try to offer an inadequate amount of compensation in the hope that the victim will accept any financial help they can get. Such offers cannot be rescinded once taken, however, so victims will not be able to pursue the compensation they are actually entitled to once they discover the true extent of their medical bills and so on.
