The potential pitfalls involved in home improvement projects become more challenging when the area within which the home is located is an area of historical importance. The Spotsylvania, Virginia, area is one such area of the country, and as such it can be daunting trying to establish what permits will be necessary for the project. Within such historical areas it is crucial that all projects to be in strict compliance with local building

laws. Homeowners are often tempted to choose a cheap contractor who is happy to go ahead and complete the project without getting the required permits. Even when a homeowner does the work themselves, such a choice can potentially be a huge mistake especially when it comes to selling the property at a later date. Obtaining the right permits is not as difficult or as expensive as most homeowners fear.

It can be tempting to think that a permit isn't needed if your family does all the work. Some people think "no one will know," or that they "don't need" the inspections that come with permitting, but the thing is that if there's a problem that should have been caught during construction and the homeowner did not secure a permit, homeowner's insurance won't cover losses at all. Building an extension to a property might not seem like something that local government needs to get involved with at first sight. Whatever a homeowner's thoughts are on the subject the fact of the matter is that local, city and even state organizations can have a legal right to specify certain things about what any homeowner can do or not do with their property. Easements, and the dreaded "conditions, covenants, and restrictions (CCRs)" that are often found in planned communities, subdivisions, or other developments, must all be considered when planning construction of any type.

These restrictions are not optional conditions that a homeowner can choose to obey or not obey. CCRs act as a type of shadow zoning ordinance and are essentially rules within rules. These restrictions are in addition to municipal ordinances, and it will be necessary to meet them in order to avoid violating the contractual agreement with a neighborhood association.

Many homeowners have come to regret not getting the proper permits for a project prior to construction. The various agencies involved with building regulations can legally force a homeowner to obtain the required permits retrospectively. Not only that, but the cost of the retrospective permits will be significantly more than they would have been if they had been obtained at the proper time.
