Compared to traditional braces, In-Ovation and Damon do not require elastic ties to secure the archwire to the braces. Instead, the small clasps work independently to facilitate the application of light, gentle pressure to the teeth over time. Much to the delight of younger patients, the colored ties, while not necessary, can still be added as a fun decoration during treatment. For teens and adults looking for more discreet options, these systems are offered as clear ceramic braces.
