One key feature of individuals who experience alcohol abuse is that they are not physically dependent on alcohol. However, alcohol abusers, if not given proper treatment and prevention, can later acquire the alcohol use disorder. Individuals with this disorder are dependent on alcohol and cannot go an extended period of time without consuming alcohol.

Futures Recovery Healthcare asserts that a person who experiences the symptoms of alcohol use disorder must seek and consult a doctor immediately. In order for the doctor to fully understand the gravity of the addiction and diagnose the individual correctly, the patient's drinking habits, lifestyle and overall health have to be checked thoroughly. Gilbert also states that the patient will be asked to undergo a physical examination that will help in identifying the physical signs that might hint at an alcohol problem. The examining doctor will use The Diagnostic and Statistical Manual of Mental Disorders fifth-edition to diagnose the individual. Once the diagnosis is made and the results show that the patient has alcohol use disorder, the doctor will then refer the patient to a series of alcohol treatment programs that will suit their addiction. These treatments may include detox programs, psychological counseling or therapies, medical prescription and continuing support programs.
