With regards to bicycle accidents, these are usually caused by drivers who are distracted or negligent. A primary cause of such accidents is failure to yield to the right of way. Many car drivers become impatient with bicyclists and as a result, they engage in risky behaviors, such as improper passing. Once again, these are cases where a personal injury lawyer can help the victim get the proper compensation for medical costs and lost wages, including the pain and suffering resulting from the negligence of another person.

Meanwhile, slip and fall accidents are quite common. These accidents usually occur when a property owner does not sufficiently maintain or monitor conditions on the property. The result is the presence of slippery floors and uneven surfaces that increase the possibility of slip and fall accidents, particularly for visitors. Victims of such accidents will need to document the scene of the accident as much as possible, get medical treatment promptly, and should never talk with a business representative or insurance adjuster until they have consulted with a personal injury lawyer.

With regards to workplace accidents, these are also common occurrences, especially for workplaces where safety practices are not followed or given priority. The workers' compensation laws in the state of Georgia provide coverage for such kind of injuries. In most cases, this will allow the worker to recover medical expenses and lost time wages. In some cases, workers may also be able to file a personal injury claim and seek additional damages for the pain and suffering. The personal injury lawyer can help with such claims, which can be brought against third parties, such as co-workers, who had intentionally or negligently caused the injury.
