And it must also be determined that the loved one?s death was caused by the negligence of another party.

and to possibly ask a number of questions. Some negotiations may also take place during this stage and it is

the task of the wrongful death attorney to negotiate a fair settlement is possible.

The last stage is the actual trial. This happens when the defendant?s legal team does not offer a reasonable

settlement amount during the pre-trial stage. Thus, having an attorney who is comfortable going to court is

essential just in case there is an actual trial.
