know whether there is a good chance for making a claim and what they need to do to maximize their chances of getting compensated. There are two things that a successful personal injury claim will need. First is assigning fault to the party who was responsible for the accident. And second, there must be sufficient compensation for damages, including medical expenses, property repair costs, rehabilitation costs lost wages, and for the pain and suffering.

Types of personal injury claims that The Brown Firm typically represents are car accidents, motorcycle accidents, truck accidents, slips and falls, medical malpractice, work-related injuries, wrongful death, dog bites, bicycle accidents, and pedestrian accidents.

Attorney Harry Brown has observed that a large percentage of auto accident victims are either injured or killed as a result of the negligence of another driver. Those who have suffered an injury during a car accident may be able to get compensation from the party at fault. This will allow victims to pay for most or all of the expenses that they incurred as a result of the accident.

For those who have been injured in a car accident, there are a number of steps that they need to take to ensure that they will get the compensation they deserve. The first step is to call the police. Second, they should take photos of the scene of the accident. Third, they should talk to potential witnesses. Fourth, they should seek medical attention. And fifth, they should consult with an experienced personal injury attorney.

Meanwhile, motorcycle accidents usually result in serious injuries that can have a lifelong impact on the victims. Motorcycle riders are often more seriously injured than other drivers because their bike provides very little protection when they get into a collision. Being a founding member of the National Academy of Motorcycle Injury Lawyers, Attorney Brown is very much aware of the importance of the rights of motorcyclists and always strives to protect them from legal harm.

With regards to truck accidents, serious and lethal injuries may be incurred when commercial trucks such as tankers, big rigs, tractor-trailers, and 18 wheelers get involved in a collision. That is why there are strict government regulations governing trucking companies. When a truck causes an accident, both the driver and the trucking company may be held liable for the resulting injuries and property damage. If any of the Federal Motor Carrier Safety Regulations were not followed and resulted in an accident, the truck driver and the trucking company will be accountable. Typically violated rules include tired drivers, improperly maintained vehicles, and violations of highway traffic and safety laws.
