There are a number of accident injury symptoms that may be delayed. These include blurry vision, headache, difficulty remembering information, inability to concentrate, clouded thinking, abnormal sleep patterns, lack of energy, dizziness, and nausea. Those who experience any of these signs after a car collision may have suffered a concussion. This is a severe injury and it is vital to seek medical attention immediately after experiencing any of the symptoms.

Another kind of injury that usually has delayed symptoms after a motor vehicle accident is soft tissue injury. This is an injury resulting from damage to the muscles, ligaments, or tendons. Typical symptoms of soft tissue injures include neck pain, back pain, whiplash, numbness, and shoulder pain. And the most notorious kind of soft tissue injury is whiplash, which results when the head is thrown back and forth during the car collision. The negative consequences of soft tissue injuries include pain, swelling, and limited range of mobility.

It is, therefore, essential for a car accident victim to consult with a car accident injury chiropractor regardless of current symptoms or injuries. The chiropractor may be able to diagnose any injuries that the victim has sustained in the accident before they become too serious and have lasting serious consequences. The insurance company will need documented proof from doctor visits to show that the accident indeed caused the injuries. Delaying consultation with a doctor or chiropractor may result in the insurance company denying the claim.
